## 840,000 HDB Households to Receive the GST Voucher - U-Save Rebate in July 2016

About 840,000 Singaporean HDB households will receive the next instalment of the GST Voucher - Utilities-Save (U-Save) rebate in July 2016. Annually, those living in 1- and 2-room HDB flats are able to offset about 3 to 4 months of utilities bills on average with their regular GST Voucher - U-Save. Those living in 3- and 4-room HDB flats are able to offset about $\mathbf{1}$ to $\mathbf{2}$ months of utilities bills on average.

## GST Voucher - U-Save

2 The GST Voucher - U-Save rebate forms one of three components under the permanent GST Voucher scheme. The U-Save rebate help HDB households offset part of their utilities bills. It is distributed every quarter and expected to cost $\$ 190$ million annually.

3 In July 2016, eligible Singaporean households will each receive a GST Voucher - USave rebate of up to $\$ 65$, depending on their HDB flat type (see Table below).

## About the GST Voucher

The permanent GST Voucher scheme was introduced by the Government in Budget 2012 to help lower-income Singaporeans. The GST Voucher is given in three components - Cash, Medisave and U-Save. GST Voucher - Cash provides lower-income Singaporeans with some cash for immediate needs, and is paid every August.

Similarly paid every August is the GST Voucher - Medisave, which provides elderly Singaporeans aged 65 and above with a CPF Medisave account top-up to support their medical needs. Lastly, the GST Voucher - U-Save provides lower- and middle-income Singaporean HDB households with quarterly rebates to offset their utilities bills, and is paid every January, April, July and October.
