1. 2013 GST Voucher

1.1 2013 GST Voucher – Cash

To have received the GST Voucher – Cash in 2013, you must have fulfilled the following criteria:

- i) You must have been a Singapore citizen residing in Singapore in 2013;
- ii) You must have been of age 21 or above in 2013;
- iii) Your Assessable Income (AI) for the Year of Assessment (YA) 2012 must have not exceeded \$24,000 (i.e. income earned in Calendar Year 2011 as assessed by IRAS);
- iv) The Annual Value (AV) of your home (as indicated on your NRIC) as at 31 December 2012 must not have exceeded \$21,000;
- v) You must not have owned more than one property in 2013; and
- vi) You must have signed up for the GST Voucher or a past Government payout (e.g. Growth Dividend or GST Credits).

1.2 2013 GST Voucher – Medisave

To have received the GST Voucher – Medisave in 2013, you must have fulfilled the following criteria:

- i) You must have been a Singapore citizen residing in Singapore in 2013;
- ii) You must have been of age 65 or above in 2013;
- iii) The Annual Value (AV) of your home (as indicated on your NRIC) as at 31 December 2012 must not have exceeded \$21,000; and
- iv) You must not have owned more than one property in 2013.
- v) You must have signed up for the GST Voucher or a past Government payout (e.g. Growth Dividend or GST Credits).

1.3 2013 GST Voucher – U-Save

To have received the GST Voucher – U-Save in 2013 (which was credited to your HDB flat's utilities account), your household must have fulfilled the following conditions:

- i) If you owned and lived in your HDB flat, there must have been at least one Singapore citizen owner or occupier in the flat; or
- ii) If you had partially sublet the HDB flat that you owned and lived in, there must have been at least one Singapore citizen owner or occupier in the flat; or
- iii) If the entire flat was sublet to you, there must have been at least one Singaporean tenant;

AND

Immediate family members living in the same flat must not have owned or have had any interest in more than one property.

1.4 2013 GST Voucher Special Payment

To help households facing cost of living pressures, the Government announced a one-off GST Voucher Special Payment in Budget 2013. This one-off payment was equivalent to an extra GST Voucher payment. In other words, all eligible Singaporeans received double the usual amount of GST Voucher in 2013.

The eligibility criteria for the 2013 GST Voucher Special Payment was the same as that of the regular 2013 GST Voucher.
